FOLLOWING THE EFFECT OF THE REGULATION OF COSMETICS, THE FOLLOWING ARE THE REGULATORY REQUIREMENTS FOR THE LISTING OF COSMETICS.

1. ABBREVIATED PRODUCT DOSSIER FOR EACH PRODUCT – COMPILED AS PER ABBREVIATED FORMAT PRESCRIBED IN THE GRANT OF MARKETING AUTHORISATION GUIDELINE.

PRODUCT VARIANTS ARE TO BE SUBMITTED ON DIFFERENT PRODUCT DOSSIERS.

- 2. COMPLETED APPLICATION FORM REFER TO GUIDELINE
- 3. COMPLETED CHECKLIST (√)
- 4. SIGNED DECLARATION ON RESTRICTED AND PROHIBITED SUBSTANCES NOT BEING CONTAINED IN PRODUCT(S) SUBMITTED FOR LISTING
- 5. TWO (02) SAMPLES IN THE SMALLEST COMMERCIAL PACK SIZES
- 6. PROOF OF PAYMENT OF STATUTORY MARKETING AUTHORISATION FEE FOR ALLIED SUBSTANCES (OBTAIN INVOICE FROM ACCOUNTS DEPT.)
  THE FEES ARE FOR AN INDIVIDUAL PRODUCT.
- 7. RELEVANT SUPPORTING DOCUMENTS I.E CERTIFICATES, ARTWORK ETC

NOTE: ALL APPLICATIONS ARE TO BE SUBMITTED TO THE AUTHORITY VIA THE ZAMRA ONLINE PORTAL. APPLICANTS ARE ADVISED TO LIAISE WITH THE ZAMRA I.T. DEPARTMENT FOR ASSISTANCE.



## **APPLICANT WORKFLOW PROCESS**

## APPLICANTS ARE ADVISED TO FOLLOW THE STEPS BELOW THAT WILL ASSIST IN SUBMITTING APPLICATIONS FOR THE LISTING OF COSMETICS.

STEP 1

• CREATE ONLINE ACCOUNT ON ZAMRA ONLINE PORTAL

STEP 2

• OBTAIN INVOICE FROM ZAMRA ACCOUNTS FOR REGISTRATION FEE TO BE PAID

STEP 3

• MAKE PAYMENTS OF STATUTORY FEE IN ZAMRA ACCOUNT.

KEEP PROOF OF PAYMENT TO BE USED AT APPLICATION SUBMISSION STAGE ON THE PORTAL.

STEP 4

• UPLOAD COMPILED ABBREVIATED DOSSIER AND SUPPORTING DOCUMENTS ONTO THE ONLINE PORTAL.

STEP 5

 SUBMIT PRODUCT SAMPLES PHYSICALLY TO ZAMRA OFFICES STATING THE APPLICATION TRACKING NUMBER GENERATED AFTER SUBMISSION OF ABBREVIATED DOSSIER
